# About the Federal Reserve System

The Federal Reserve Act of 1913 established the Federal Reserve System as the central bank of the United States to provide the nation with a safer, more flexible, and more stable monetary and financial system. The Federal Reserve System includes the Board of Governors, located in Washington, D.C., 12 regional Federal Reserve Banks located around the nation, and the Federal Open Market Committee, which sets U.S. monetary policy.

# About the Federal Reserve Bank of Kansas City

The more than 2,000 employees of the Federal Reserve Bank of Kansas City serve the public across a seven-state region that includes Colorado, Kansas, Nebraska, Oklahoma, Wyoming, northern New Mexico and western Missouri. Headquartered in Kansas City, Missouri, the Kansas City Fed also has Branch offices in Denver, Oklahoma City and Omaha.

## About the Omaha Branch Board of Directors

Each Branch of the Federal Reserve Bank of Kansas City has its own seven-member board of directors. Four directors are appointed by the Federal Reserve Bank of Kansas City, and three are appointed by the Board of Governors of the Federal Reserve System in Washington, D.C. Branch directors serve three-year terms and provide their respective Branch executives with insight on regional economic conditions as well as offer advice and counsel.
