SUMMARY OF CURRENT NEBRASKA ECONOMIC CONDITIONS

Nebraska's economy continued to strengthen during the third quarter of 2021. Nebraska added 8,000 new jobs and ended the quarter with an unemployment rate of 2.0%, the lowest in the nation. However, while employment in most industries has recovered fully, total payroll employment is still 16,000 below pre-pandemic levels. Particularly, leisure and hospitality, and state and local government have not fully recovered the employment losses that occurred in 2020. After declining during the first two quarters of 2021, the size of the labor force increased by 1,800 workers during the third quarter. Personal income growth declined during the second quarter, primarily due to a decrease in contributions from transfer payments. The Nebraska housing market also strengthened, as home prices exhibited 15.1% year-over-year growth during the second quarter, and single family and multifamily housing permits increased by 13.2% and 25.7%, respectively.

This databook provides current economic indicators to help monitor trends and allow comparison of past information. These indicators include employment; employment by industry; county and state unemployment; personal income; home prices; housing indicators; manufacturing activity; oil, gas and coal production; and exports. 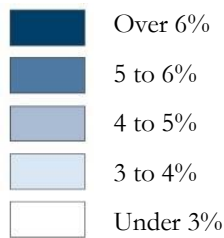
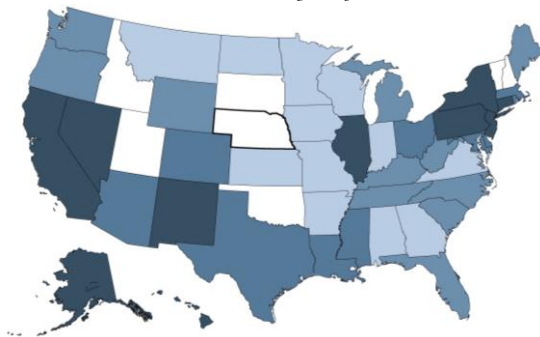

Seasonally Adjusted

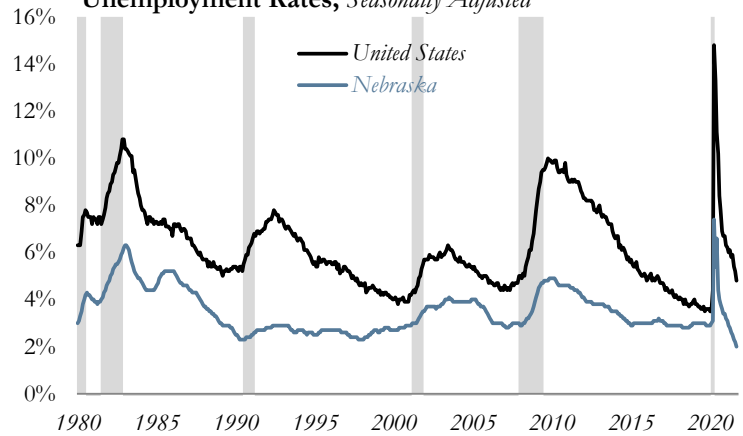
September 2021 Unemployment Rates

Unemployment Rates, Seasonally Adjusted



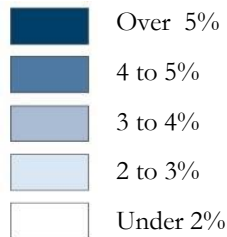
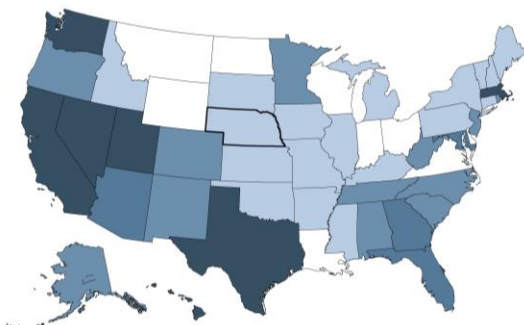

September 2021 Payroll Employment

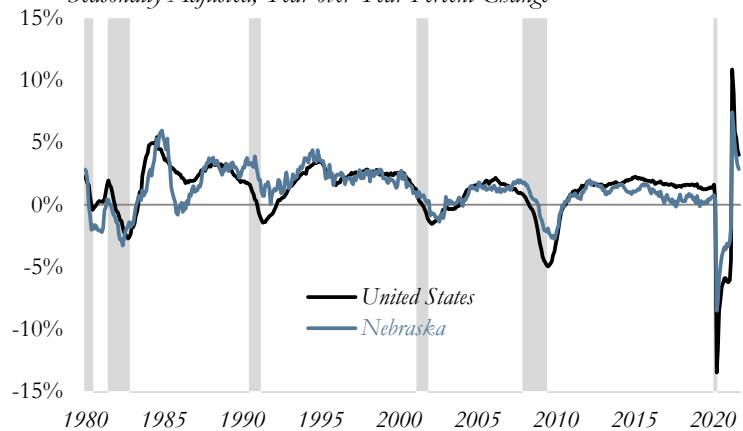
Seasonally Adjusted, Year-over-Year Percent Change

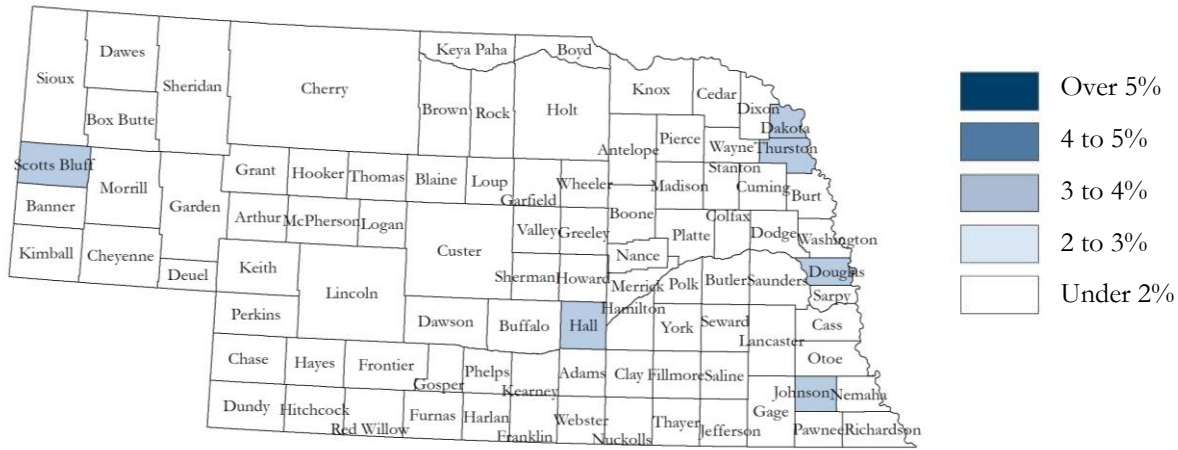
Seasonally Adjusted, Year-over-Year Percent Change

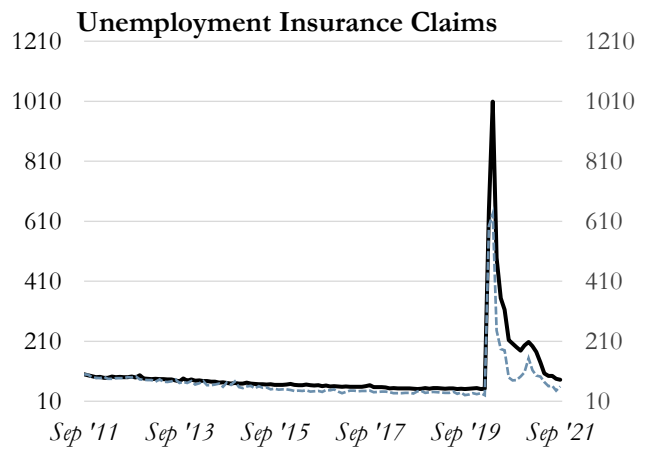

Ten-Year Index of Growth, Seasonally Adjusted

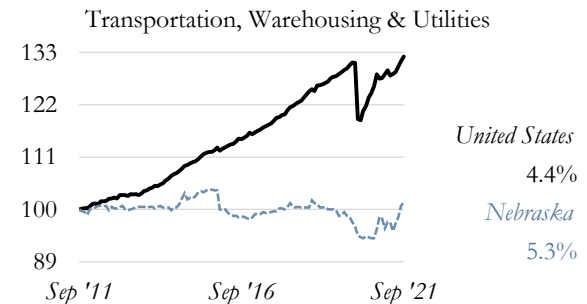
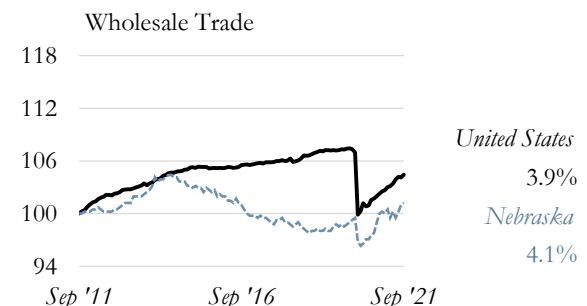
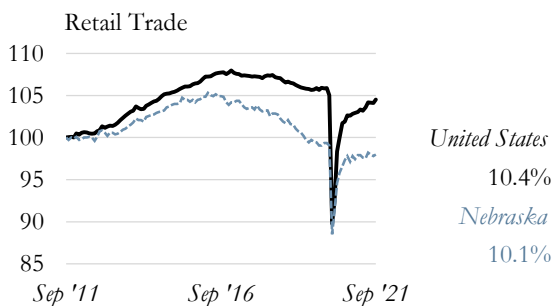
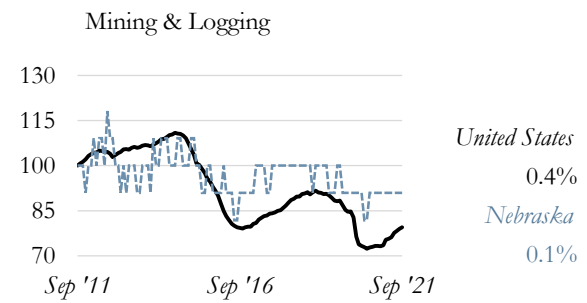
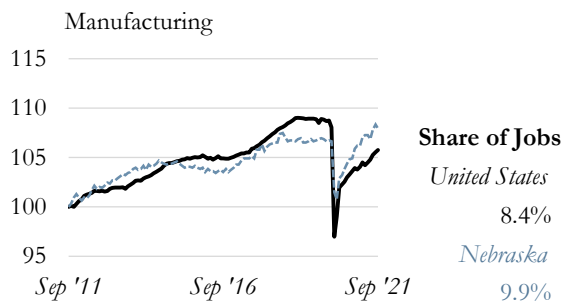
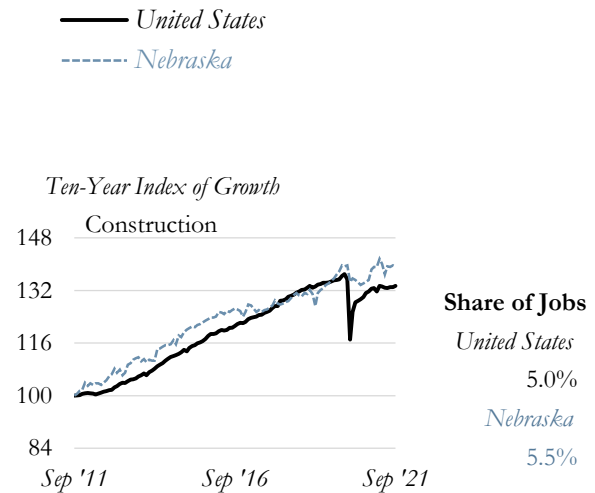
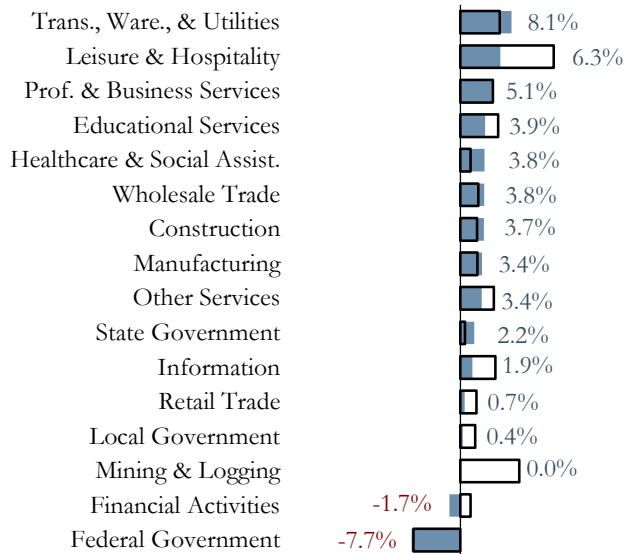

September 2021 *Percent Change Year-over-Year*

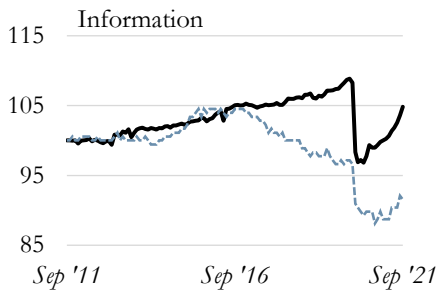

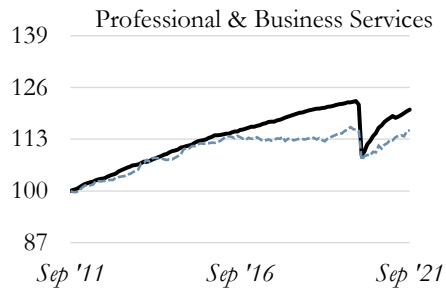
Payroll Employment by Industry

Ten-Year Index of Growth, Seasonally Adjusted

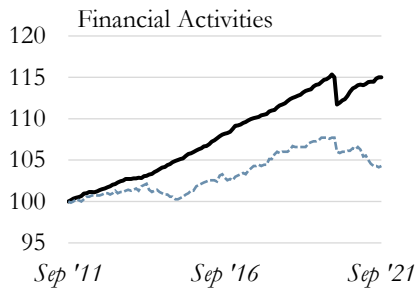

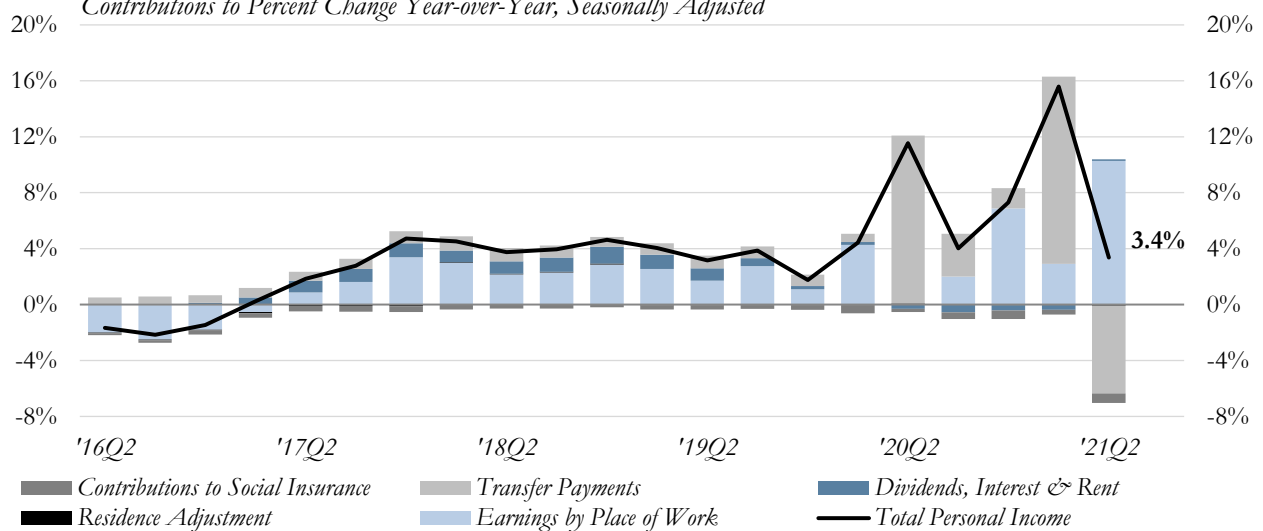

Contributions to Percent Change Year-over-Year, Seasonally Adjusted

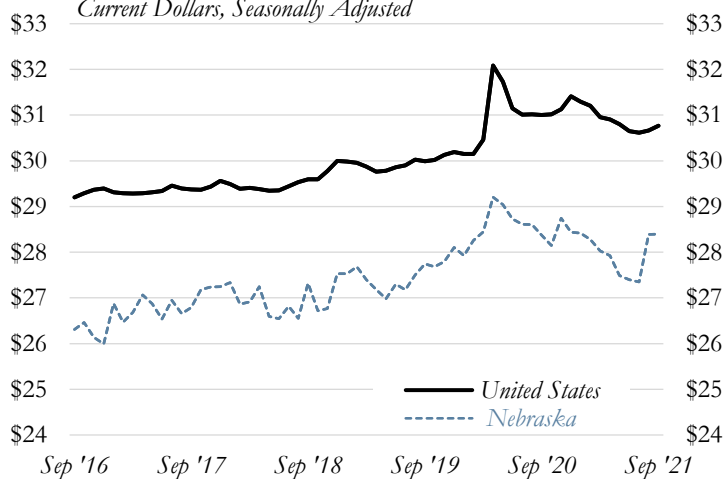

Real Average Hourly Wage

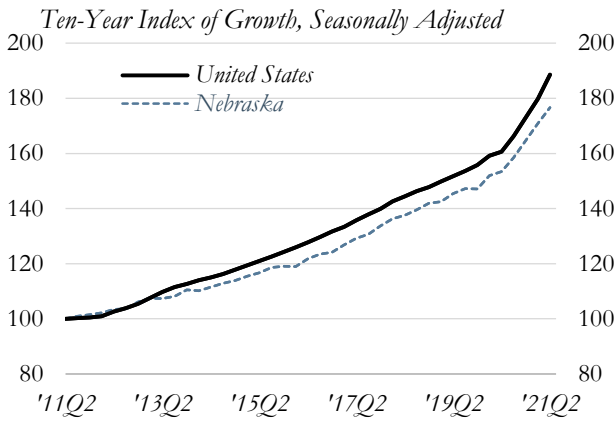
Current Dollars, Seasonally Adjusted



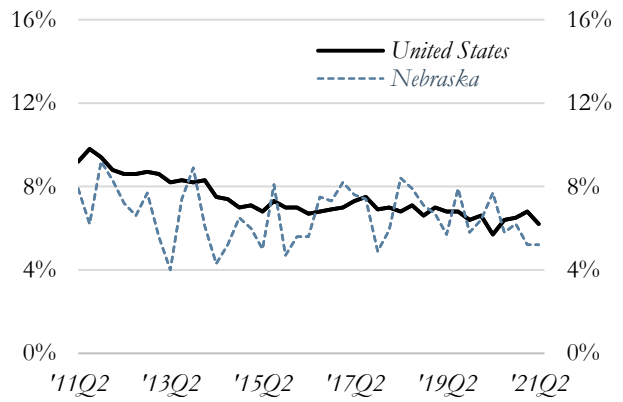

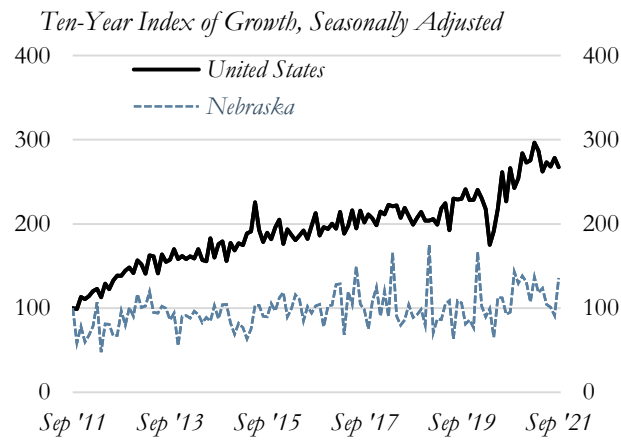
FHFA Purchase-Only Home Price Index

Housing Permits

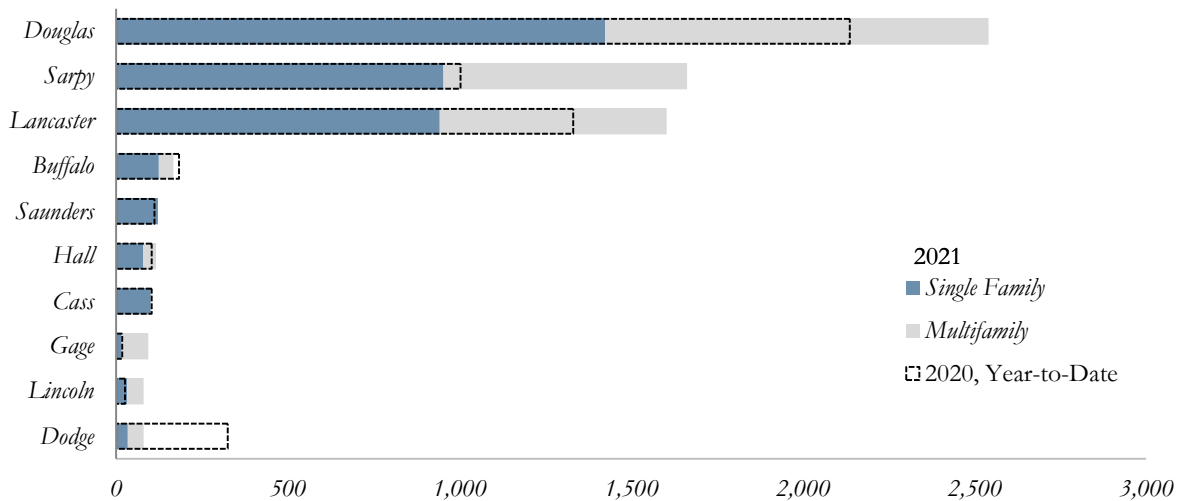

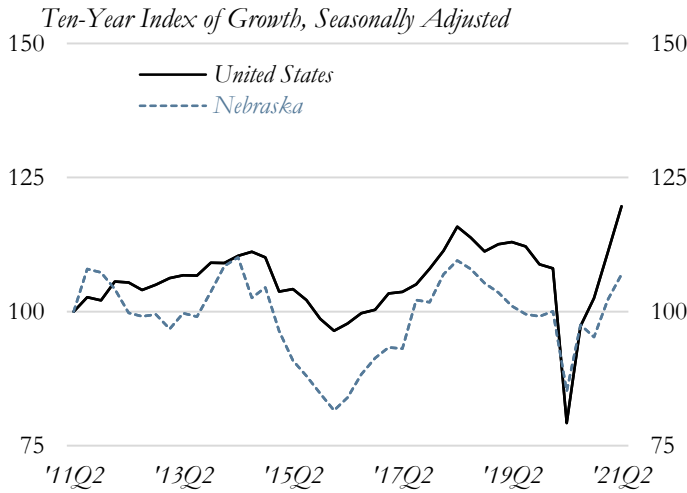
Top 10 Nebraska Counties for Permit Activity

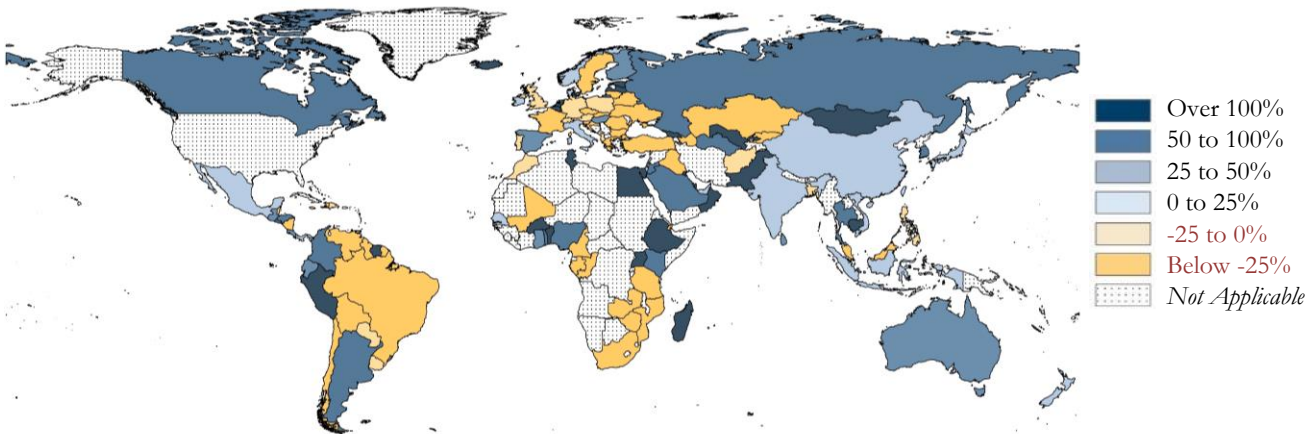

Pages 2 - 4: County unemployment rates typically lag state data releases by one month. Gray bars show recessionary periods as designated by the National Bureau of Economic Research. The "official" and most commonly reported unemployment rate is calculated as the number of unemployed workers divided by the total civilian labor force. These data are reported from the Bureau of Labor Statistics Current Population Survey, or commonly called the "Household" survey.

Page 5: Nonfarm employment data from the Bureau of Labor Statistics Current Employment Survey are commonly called "Payroll" employment data. Estimates from this survey are revised throughout the year and a major revision or "benchmark" of the data occurs in March of each year. "Payroll" and "Household" surveys are released monthly, providing the most current estimates of employment published by the Bureau of Labor Statistics. Initial claims show monthly applications for initial claims for state unemployment insurance benefits.

Pages 6 and 7: Payroll employment by industry is shown for each of the major two-digit North American Industrial Classification System industries.

Page 8: Personal income provides a measure of all income received by residents of a given geographic area. Data shown are in nominal terms (not adjusted for inflation). Transfer payments include social benefits such as unemployment insurance, Social Security, and Medicaid. Contributions to social insurance are subtracted from personal income. These contributions include taxes paid by businesses and employees that support social insurance programs such as unemployment insurance, Social Security, and Medicaid. The residence adjustment adds income received outside of a recipient's state of residence and makes a corresponding subtraction from the area where this income was earned or received. Real average hourly wages are calculated as total earnings divided by total employment for a given geographic area. Data are adjusted for inflation using the consumer price index for all urban areas (CPI-U) and are indexed to the most current month of data.

Page 9: Home price indices estimate regional growth in home values based on repeat sales data for detached single family residential properties. Monthly single and multifamily housing permits data are not revised and therefore may not sum to published year-end totals.

Page 10: Exports measure the total physical movement of a given product from the United States to a foreign country.

Data Revisions

Most data are revised periodically to correct for errors and incorporate additional information as it becomes available. Data shown in this report are subject to change.

Seasonal Adjustments

Most data are seasonally adjusted to remove variance caused by seasonal fluctuations in economic activity. Data in this report show the seasonal adjustments of data publishers where available. In other cases, Census X-12 adjustments were applied.
