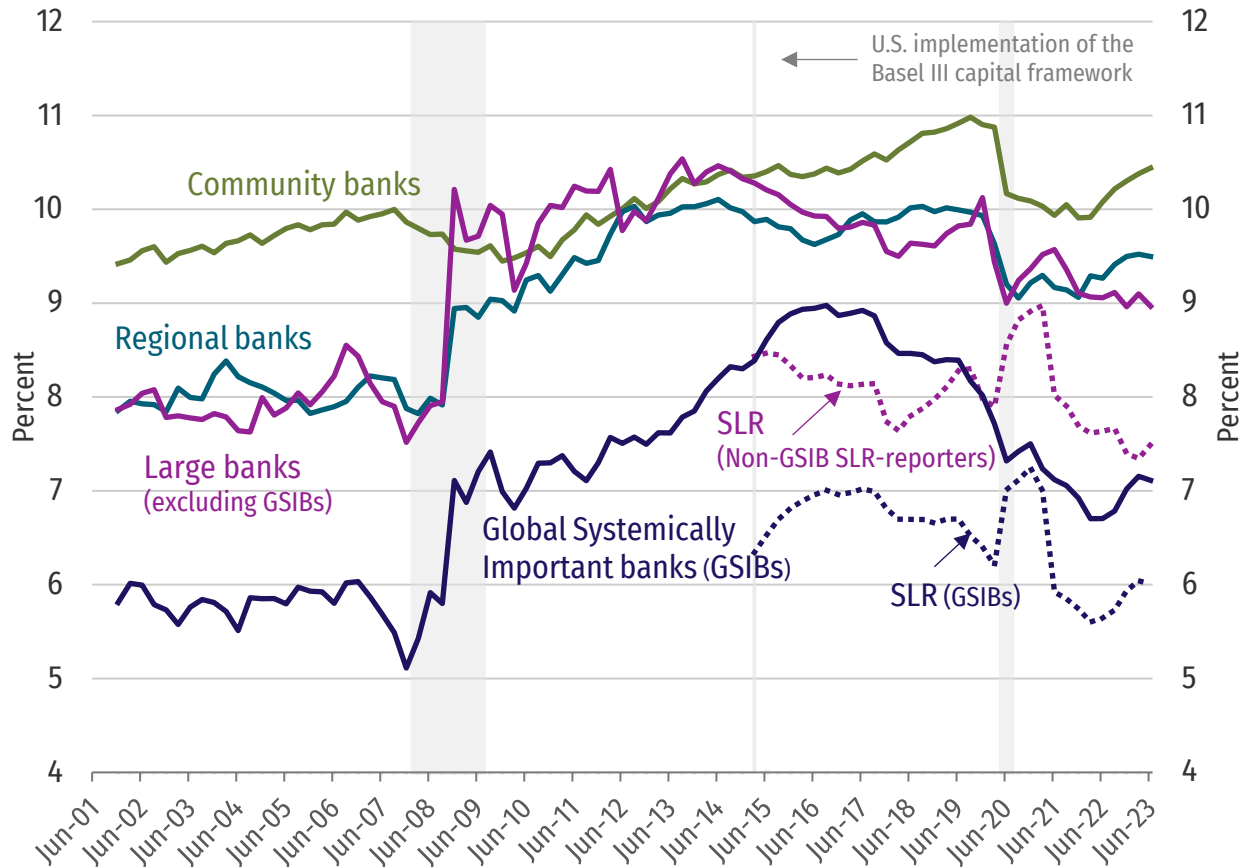

## Supplementary Leverage Ratio (SLR) and Tier 1 Leverage Ratio

U.S. banking organizations by supervisory portfolio group (% weighted average)



Notes: Tier 1 capital as a percent of total leverage exposure (for SLR) and as a percent of average total assets (for Tier 1 Leverage ratio). SLR reported only by banking organizations that generally have assets greater than \$250 billion or on-balance sheet foreign exposures above \$10 billion. Portfolio groups are established by the federal banking agencies and reflect the group banking organizations were in as of 8/29/2023.
