Tenth District Manufacturing Activity Declined Somewhat in September

Regional factory activity declined somewhat in September. District production decreased while employment stayed steady, and access to credit has remained unchanged for a strong majority of manufacturing firms.

Tenth District Manufacturing Activity Was Unchanged in August

Regional factory activity was basically flat in August. Firms also reported another decline in finished product prices but anticipate output prices to rise in the coming months.

Regional factory activity continued to decline in July. District production decreased moderately, while employment activity picked up slightly and is expected to increase further.

Regional factory activity declined further in June. District firms' expectations for future activity fell to their lowest levels since April 2020, although firms were still fairly optimistic about employment levels.

Regional factory activity was largely unchanged in May. Prices cooled significantly over the last month and year and are expected to cool further.
