- Organize events and programs ranging from symposiums on the housing market to small business funding to local nonprofit conferences to bring economic information and resources to underserved communities.
- Meet with and speak to community and business organizations about economic conditions in the state and gather information and insights about diverse perspectives on the economy.

About the Federal Reserve Bank of Kansas City

The Federal Reserve Act in 1913 established a framework for a decentralized central bank, one that included a regional structure of 12 Reserve Banks around the country. The Act also extended that regional presence by providing for Branch offices.

The Federal Reserve Bank of Kansas City serves seven states: Kansas, western Missouri, Nebraska, Oklahoma, Wyoming, Colorado and northern New Mexico. There are three Branches in the Tenth District in Denver, Oklahoma City and Omaha.

Esther George is president of the Federal Reserve Bank of Kansas City. She serves on the Federal Open Market Committee, which has authority over U.S. monetary policy.
